#### Open for contribution

Keith Harland, from Fire & Rescue Service described difficulties with language barrier during fire and rescue operations.

Peta Mettam also talked about the difficulties of language barrier they have been experiencing at the Citizens Advise Service Three Rivers, (CASTR), due to a rise in housing issues, although CASTR use Language Line, which offers remote and on-site interpreting and translation solutions for various industries and organisations.

Shivani Dave advised that Three Rivers District Council's (TRDC) website includes an accessibility tool provided by *Recite me* that provides access to several languages.

Michelle Wright from TRDC shared a presentation on Violence Against Women and Girls, which covered the following points:

Michelle Wright highlighted concerns around unlit car parks, particularly in Abbots Langley, and the need for data around antisocial activities as well as how partners can work with schools.

The Police are working with TRDC, improving lighting and CCTV cameras. TRDC have also installed solar lights in parks.

Dan Bhamra from Hertfordshire Constabulary shared that the college of policing are developing something with Herts constabulary staff, and more information would be shared as this progresses.

Peta Mettam talked about the importance of training staff in violence against women within organisations.

Keith Harland recommended Hertfordshire County Council's Active Bystander training.
