LI5/25 REVIEW OF STATEMENT OF LICENSING POLICY 2021-2026

The Development Management Team Leader introduced the report.

Key points included the distinction between commercial license applications and community or charity events, with an emphasis on facilitating easier access for smaller groups who may struggle with digital submissions. The conversation highlighted the challenges faced by applicants unfamiliar with online systems, the importance of maintaining some flexibility for paper applications, and the need for clear, simple guidance to help community members understand licensing requirements. Suggestions included incorporating explanatory information about temporary event notices into the policy, creating easy-to-read guides, and enhancing communication through parish council and social media, especially around

common event times. The discussion also covered the prompt validation process for applications and the role of licensing officers in providing personalised assistance.

Councillor Harry Davies moved the recommendation as set out in the report to Commence a 6-week public consultation exercise on the revised Policy.

On being put to the Committee, the motion was declared CARRIED by the Chair, the voting being by general assent.
