Summary of the project proposal	The Cricket Club (and Sports Club) are faced with a number of significant issues which are ultimately hindering both cricket and other sports from flourishing in what should be a perfect location for team sports.
	To enable the various users of the Park Road site to grow and ensure the local community has a facility which encourages both improved capacity and the ability to support successful team activities, a number of major infrastructure changes are needed which are currently outside of the ability of the two clubs to fund independently.
	The proposal covers the following:
	<ul> <li>Drainage Enhancements to address flooding issues (Turfdry). This will cover both playing areas and will look to address the existing drainage issues through the digging and filling of trenches 5m apart with a drainage system installed at the bottom of each trench.</li> </ul>
	<ul> <li>New cricket nets to double existing capacity (Total-Play). East side of the ground between the two main playing areas. It is not possible to expand the existing net structure due to encroachment onto the playing area and safety issues arising as a result.</li> </ul>
	<ul> <li>A new changing facility for the top pitch to replace the existing delipidated structure on the west side of the top pitch of the ground (Mac-Containers)</li> </ul>

	We have received a substantial donation towards the project from Batchworth Community Council (£24k) and are currently awaiting a response from Croxley Green Parish Council regarding how much they will allocate the project from

	their CIL fund (expected in September 2025). We have been led to believe that they will match the donation from Batchworth as this will fund the project to the 75% level which is the CIL split ratio between the parish councils and TRDC. Why is CIL funding being sought and who are the likely beneficiaries of the project? Please provide usage details where appropriate

The improvements to the site's infrastructure can't be achieved without external funding.

Cricket is the predominant sport played in the summer months, however the Sports Club is used over the winter by various youth teams from Croxley Green Football Club (a significant proportion of which are girls teams).

The cricket club is currently going through a period of unprecedented success on the playing front and has also seen the youth sections (both boys and girls) expanding at a tremendous rate.

The club runs 5 adult Saturday league teams (for the first time in the club's history – the new 5<sup>th</sup> team is to be used to specifically integrate younger players into the adult game), 1 Sunday team, 9 boys teams and 3 girls teams. In all, we have in excess of 200 playing members on the books.

The facilities are used every day over the summer months for either cricket matches or practice. In the winter months football is played at the weekends when the ground is suitable (i.e. is not flooded).

The club would like to begin offering access to disabled sports users however the soft ground and current pavilion entrance area are ill-suited for this without an overhaul.

How does the project help address the demands of development in the area. What evidence is there to support this?

The extensive flooding experienced in the 2024 season, saw the club being unable to fulfil home fixtures at Park Road for most of the season. A huge number of man hours were expended trying to find alternative venues for games which proved to be both difficult and expensive. In many cases the only alternatives were sub-standard council grounds as far afield as Hemel and Welwyn.

The club was extremely fortunate that a number of opposition teams showed tremendous goodwill by offering to switch fixtures. Due to promotions, it is unlikely that this could be repeated in 2025.

The situation was so extreme that as an example, the 3rd XI was only able to play two home fixtures out of 12 at Park Road all season. This situation is not considered sustainable moving forward.

The youth sections of the cricket club are currently running at capacity for existing facilities. Despite being a CASC, the cricket club have to warn prospective members that even though they are welcome to join there is no guarantee of access to practice facilities / game time etc.

To enable more members access to suitable facilities the club needs to double its existing net capacity from 2 lanes to 4 lanes (as an example West Herts CC has 4 outdoor net lanes). The existing nets do not meet the current guidelines as defined by the ECB.

The existing facilities (even once refurbished) are not currently comparable vs many other clubs in the area. Be that either pitch condition, changing areas or practice facilities. This makes it

	extremely difficult to maintain talented youngsters and attract better players that will enable the club to grow and play at a higher level.
	The club would like to grow its female section substantially. It currently runs three girls teams (oldest being U15). The club would like to begin an adult women's teams but is currently losing older girls players to more established clubs as far afield as St Albans.
	The configuration of the existing pavilion does not allow for separate changing areas for the female teams. Enhanced changing facilities at the top end of the ground would go a long way to remediating this issue. The existing toilet / showering facilities are not adequate to support female sport.
	Disabled access to the pavilion is extremely poor and there are currently not disabled access toilets. Coupled to issues with the drainage on the site there is extremely limited ability to support disabled sporting activities. The club was approached in 2024 however was unable to fulfil the request due to the issues outlined.

Would the community support the project? Please refer to CIL Scoring Criteria Guidance under: Community Support	The quality of sports facilities in Rickmansworth is far below that of Chorleywood and Watford (e.g. Chorleywood CC, Chorleywood Common FC, West Herts CC etc.) This means that at present many players are going outside of the immediate area to access a superior playing experience. It is hoped that the improvements will enable local schools to work in partnership with the clubs to provide superior coaching opportunities than is currently possible.
	The club has researched vendors who are approved by Sports England and the English Cricket Board. This will ensure that the solutions are in line with best practice guidance and also ensure the product is of

sufficient quality to maximise the playing experience of those using it.

The club is attempting to source alternative funding where possible and has renewed it's sponsorship packages to encourage support from local businesses. The cricket club is in the process of securing ECB Clubmark status which we hope will open up future funding opportunities, however the costs involved are significant and it is highly unlikely that material funding can be secured to facilitate the improvements to be made in the required timeframes (i.e. fully completed for Summer 2026).


As part of the Clubmark application there is a requirement for the club to produce a long-term development plan. This has been disseminated around the club membership and there has been broad agreement that the enhancements outlined in this project will remediate the key challenges faced by the clubs.

# **Evidence of Public Support**


The club obtained details of the CIL application requirements relatively late in the Jan - Feb 2025 application process. Consequently, it had a short period of time to obtain evidence of external public approval for the project.

At the request of Three Rivers Council, the club opened up a Petition to members and supporters which remained open for just 48 hours. In this time we had 385 responses. No doubt given more time we could have increased this number manyfold.

The Petition asked participants to support our request for funding assistance to enable better drainage for the Ground; 2 brand new nets on the side of the ground so we have enough for both boys and girls on practice nights, improved changing facilities on the 2nd ground; secure storage space for machinery; better security and disabled access across the front of the Pavilion. All 378 participants agreed to support this. The vast majority of people filling in the form were over 18.



We then asked respondents what was their involvement in the Club. Almost 50% had some kind of involvement with the club as a player or through family connections. 20% were actually members of other local clubs who wanted to post their support for the clubs endeavors.



328 of the respondents reside in the WD3 postcode, whilst another 25 live in other parts of Watford. This means 86% of those responding are Three Rivers District Council residents and a further 7% are in neighbouring Watford.

Prior to the online survey we thought it would be useful to obtain some feedback by utilising the local Facebook groups for both Croxley Green and RCCG (Rickmansworth, Chorleywood & Croxley Green). The post below was made on both groups with anyone supporting the application for funding to 'Like' the post and provide a comment if they wanted.

Feedback was overwhelmingly supportive with some extremely constructive comments and over 300 'Likes' being received within the first three days (Link 1 / Link 2). Whilst we now appreciate that Facebook likes are not recognized in the CIL application process we received many supportive comments from people who do not have a known connection to the cricket club (examples of the comments have been included and can be referred to in the supporting document 'CIL Request Supporting Information.pdf' Page 20.

We have obtained a letter of support from Croxley Green Football Club for the proposed drainage works. This has been supplied in Appendix 4 of this document.

# Please outline how the project will demonstrate value for money

There is currently limited capacity for growth of cricket on the site. Capacity has been reached with the existing facilities and coupled to flooding and the associated subsidence, it is unlikely that the situation will improve.

Sport is obviously key to the wellbeing of anyone involved and it is hoped that the proposed improvements will ensure that there is a quality offering for generations to come i.e. the proposed changing area has a 50+ year lifespan, the net base has a 36 year warranty, the drainage solution has proven to be enormously successful everywhere it has been installed.

Sport England Sport has conducted an analysis which has highlighted and physical activity contribute significantly to the health and wellbeing of England. Their model highlights the social value created by community sports, estimating that over £107 billion in social value was generated in 2022/23 alone.

This figure represents both primary value - the wellbeing benefits that individuals experience from being active - and secondary value, which reflects the cost savings to public services like healthcare (<u>Link</u>).

Based on the figures in this model we have extrapolated out the estimated benefits of conducting the project. Our analysis shows that we would expect the project to be cost neutral within 3 years (1.7 years if the drainage enhancements alone are considered).

Our calculations have been included in the supporting documentation for this application.

# Would the project lead to any income generation?

Please refer to CIL Scoring Criteria Guidance under: Project Cost Improved net infrastructure will enable the club to rent out facilities to cricket activators. At present the club does this however is on an extremely limited basis.

Drainage enhancements would make the outfields fit for use all year round and therefore enable the pitches to be hired out more frequently i.e. for disabled sport / county representative sides etc. This was possible in 2023 however was not possible in 2024 due to the flooding issues.

Ideally the club would like to engage with local schools and work in partnership with them to provide coaching opportunities which currently are ill suited to the site. Whilst this may not generate revenue, it will hopefully improve the provision of cricket to the children of Rickmansworth and Croxley Green across all age groups.

Additionally, we have put together an analysis of financial benefits to the community based on an activity study put together by Sport England. Whilst this is not direct income it is based on reducing costs as a result of inactivity. A full breakdown of this can be found in the supporting document 'CIL - Financial Benefit Analysis'

Because of the need to cover both VAT and delivery charges, we face a significant shortfall of £40,395 (£35,751 is VAT and £4,644 delivery charges) which we are aiming to cover through match funding  The Cricket Club has received funding from Batchworth Community Council (£24k) and has applied to Croxley Green Parish Council. We understand from that our bid will be looked upon favourably, however we will not know the extent of any donation from CGPC until after the date of this submission.  We have also applied for grant from Veolia (unsuccessful as over-subscribed) and also the Hertfordshire Community Foundation.  There are major infrastructure works required in the Pavilion which fall outside of the scope of this bid (Roof replacement and Toilet Upgrades amounting to >£200k). After investigation, we understand that we fall on the outer limit of the HS2 boundary and would therefore like to try utilize this source of potential match funding for completing these essential works. It should be noted that HS2 have requested an update to the Cricket Club lease agreement prior to any application which is currently being worked on (no problems are anticipated with these updates). Thank you for submitting a grant application to the Veolia Environmental Trust.

At their meeting on the 03/06/2025, our Trustees carefully considered your application but unfortunately were unable to award a grant towards your project.

Regrettably, we do not have the funds available to support every application we receive. Our Trustees have to make difficult decisions, and award grants to the projects they feel most closely match Trust priorities. They recognise the amount of hard work you put into your application and are very sorry to disappoint you.

As our funding scheme is over subscribed, we recommend that you wait at least 12 months before reapplying with a new application for a grant at this project site. You may wish to apply for funding from other Distributive Environmental Bodies in your area and information may be obtained from ENTRUST, the regulatory body, via their website www.entrust.org.uk

Thanks very much for your email.

I am broadly familiar with this area and some former colleagues were involved in some investigations to try and address some of the flooding in the area. We would have no concerns with the drainage system itself but it is worth noting that we understand there are some issues downstream whereby the watercourse it is intended to discharge into it blocked or damaged. Previous officers believed there could be an obstruction between the locations labelled I and O which were prohibiting the watercourse from draining effectively. Unfortunately I don't think we have made much progress with these investigations since the staff involved left. I recall there were some difficulties in establishing who is responsible for the culverted length of watercourse between the cricket club and point O in Fortune Common.

I believe TRDC were undertaking a survey to try and establish where any issues in the culvert might be and who would be responsible for clearing it (it will likely be the owner of the land above the culvert). I've just asked if there are any updates they could share.
