EAST LANE MEMORIAL CLEANING (ADE)

1 Summary

- 1.1 The memorial markers at East Lane Cemetery, a heritage site, have become covered in moss and detritus over the years, making it difficult and, on many, impossible to read. A number of markers have also become detached from their plinths.
- 1.2 These markers require fixing and cleaning, so that the history of the site can be maintained in a respectful manner and people can be properly traced.
- 1.3 This work will be funded by the Management and Maintenance grant funding held in Reserves for Leavesden Country Park as part of the original Lottery Funded project.
- 1.4 An exemption form has been completed for this work, due to the specialist requirements, limited market and having only received one quote.

2 Recommendation

2.1 That the exemption form is noted.

3 Details

- 3.1 The memorial markers at East Lane Cemetery, a heritage site, have become covered in moss and detritus over the years, making it difficult and, on many, impossible to read. An unknown number of markers have also become detached from their plinths.
- 3.2 A number of markers are broken and these will not be mended or replaced, however they will be fixed back to their plinths in pieces.
- 3.3 The cleaning works needed require the engagement of a specialist contractor using a specific steam-based stone cleaning system.
- 3.4 As there was little interest to carry out this work officers approached both the company who carried out the initial work at East Lane, as well as a specialist memorial safety company. Only one of the companies submitted a quote despite officers chasing
- 3.5 There is currently no date for the works to commence, however officers are working with the company to arrange a suitable date.
- 3.6 The Leavesden Hospital History Association will be notified of this work in advance.

- 3.7 This work will be funded by the Management and Maintenance grant funding held in Reserves for Leavesden Country Park as part of the original Lottery Funded project.
- 3.8 An exemption form has been completed for this work, due to the specialist requirements, limited market and only having received one quote. This exemption has been and signed off by the Chief Executive and Associate Director for Environment.

4 Options and Reasons for Recommendations

4.1 The recommendation is for Committee to note the report, as an exemption form has already been signed off, for the reasons outlined.

5.1 The recommendations in this report are within the Council's agreed policy and budgets

6 Financial Implications

- 6.1 There are 515 markers to be cleaned at £20 each £10,300 (inc VAT £12,360)
- There is a maximum of 515 markers to be fixed back to their plinths, however the exact number is unknown until the company is on site. Therefore, this is a worst case quote at £25 each £12,875 (inc VAT £15,450)
- The most these works will cost will not exceed £23,175 (£27,810 inc VAT), which can be met from the Management and Maintenance grant funding held in Reserves for Leavesden Country Park as part of the original Lottery Funded project.
