PART I

WREATH LAYING PROTOCOL (ADLDS)

1 Summary

- 1.1 Members requested that the Wreath Laying Protocol be reviewed following some questions asked at Council about the protocol following its circulation ahead of Remembrance Sunday in November 2022.
- 1.2 Members asked that the protocol come forward to the Committee so all Members are able to review the protocol and put forward suggestions for amendments for the Committee to consider ahead of the services in November 2023.
- 1.3 As part of the review the protocol was circulated to all Members twice ahead of the report publication so that the comments received could be provided for the Committee to consider.
- 1.4 The new protocol is attached at Appendix 1.

2 Details

2.1 It is requested that the Committee consider the following amendments to the protocol as follows:

Members can only lay wreaths in their own Wards

Wreaths can only be laid on Remembrance Sunday or 11 November (Remembrance Day)

The only people who can lay wreaths outside a Ward, in order of preference, are:

The Chair of Council

Armed Forces Covent Holder or

Leader of the Council

2.2 The Committee are asked to note that the Chair of the Council was in the past invited to attend the Battle of Britain Service each year to lay a wreath, but this service now no longer takes place and is not included in the suggested new protocol.

3 Options and Reasons for Recommendations

3.1 The Committee are asked to agree the new protocol at Appendix 1.

4 Policy/Budget Reference and Implications

4.1 The cost of purchasing the wreaths in 2022 was £400 with the charity donation payment being made from the Democratic Representation budget.

5 Financial Implications

5.1 The proposals are within existing budgets.

8.1 The organisation of getting the wreaths and purchasing them is managed by the Committee Team with the Council paying a donation to the Royal British Legion for the wreaths. We also organise obtaining all the information details on each wreath laying ceremony that is held on Remembrance Sunday across the District. Ahead of Remembrance Sunday details are passed to Communications/Digital Services Team.
