



Q1. Please provide your comments on the review of our Street Trading Policy 2022-2025

It is pleasing to see TRDC have taken on board the Parish Council's comments that the requirement for a street trading consent in the context of community and charitable events is wholly disproportionate, given the additional administrative burden placed on organisers (including volunteers) and particularly where a charge is levied against a background of no obvious harm being created by such events to address/ remedy. The Parish Council, in particular, welcomes the addition of paragraph 2.3.2 to the policy which will mean, if it is adopted, that events like Village Day, as well as school fetes and events provided by charitable and community organisations, such as Chorleywood Community Initiatives' Christmas Festival, will be the exempt from the requirement to apply for a street trading consent going forward.



-The proposed revised Street Trading Policy is a vast improvement on the previous. -Both documents demonstrate the difficulty in legislating for both charity/community and purely commercial traders/events within a single policy. It would be great if they could be differentiated further. -The difference between Street Trading Consent and Street Trading License is not clear (at least not to me). -Typo: Exceptions as mentioned in 1.6 should be directed to 2.3, rather than 3.3. -"Activities which take place within the boundaries of school premises are exempt". But no mention of churches/religious sites? - The TRDC web page for Street Trading says: " You do not need a consent to hold a charity or community event if the following apply: traders are invited to trade by the event organisers the money raised by individual stalls/traders is donated to charity" I cannot see that these important notes are mentioned with the proposed policy document? - I was only made aware of this review and the opportunity to comment when I contacted Licensing. Is there a mechanism for involvement? Are we able to register an interest? Thank you.
