DIRECTION UNDER THE TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) (ENGLAND) ORDER 2015

Modification of the Article 4 direction made by Three Rivers District Council on 23rd September 2022 in relation to development consisting of Class MA change of use from commercial, business and service (Class E) use to residential (Class C3)

The Secretary of State for Levelling Up, Housing and Communities, in exercise of the powers conferred by paragraph 1(13) of Schedule 3 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) and of all other powers enabling him in that behalf, makes the following direction:

Interpretation

- 1. In this Direction-
- " General Permitted Development Order" means the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended); and
- "Article 4 direction" means the Direction made by Three Rivers District Council under Article 4 of the General Permitted Development Order on 23rd September 2022 in respect of development consisting of a change of use of a building and any land within its curtilage from a use falling within Class E of Part A, Schedule 2 to the Town and Country Planning (Use Classes) Order 1987 to a use falling within Class C3 (dwellinghouses) of Schedule 1 of that Order, namely development which is permitted by Class MA as inserted into Part 3 of Schedule 2 to the General Permitted Development Order. The Article 4 direction relates to sites in Three Rivers District Council.

Direction

- 2. The Secretary of State hereby directs that the Article 4 direction is modified as follows:
- 3. Instead of the Article 4 direction applying to land described in the Second Schedule to that direction and the attached maps, comprising sites within Three Rivers District Council, it shall apply only to the land specified in this Direction.
- 4. The specified land is the areas outlined and shaded red on the attached maps, relating to the following sites:
 - Croxley Business Park
 - Maple Cross / Maple Lodge Employment Area
 - Tolpits Lane Employment Area
 - Kings Langley
 - Leavesden Park
 - Rickmansworth Town Centre
 - Chorleywood District Centre

- Abbots Langley District Centre
- South Oxley District Centre
- 5. For the avoidance of doubt, this Article 4 Direction does not apply to any land outside the areas outlined in red.

Entry into force

6. This Direction comes into force in accordance with paragraph 1(18) of Schedule 3 of the General Permitted Development Order.





Maps showing Article 4 Direction coverage




Maple Cross / Maple Lodge Employment Area (not modified)






