Registering Interests

Within 28 days of becoming a Member or your re-election or re-appointment to office you must register with the Monitoring Officer the interests which fall within the categories set out in **Table 1** (**Disclosable Pecuniary Interests**) which are described in 'The <u>Relevant Authorities (Disclosable Pecuniary Interests)</u>. You should also register details of your other personal interests which fall within the categories set out in **Table 2** (**Other Registerable Interests**).

"Disclosable pecuniary interest" means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Table 1 below.

"Partner" means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

- 1. You must ensure that your register of interest is kept up-to-date and within 28 days of becoming aware of any new interest, or of any change to a registered interest, notify the Monitoring Officer.
- 2. A 'sensitive interest' is an interest which, if disclosed, could lead to the Councillor, or a person connected with the Councillor, being subject to violence or intimidation.
- 3. Where you have a 'sensitive interest' you must notify the Monitoring Officer with the reasons why you believe it is a sensitive interest. If the Monitoring Officer agrees they will withhold the interest from the public register.

(b) Any body exercising functions of (i) a public nature; directed to charitable (ii) Trustee of Abbeyfield Wesy Herts Society purposes; or (Charity number 265137) (iii) whose principal purposes include the influence of public opinion or policy (including any political party or trade union). 2. Any person or body from whom (registered individually if applicable) you have received a gift and/or hospitality with an estimated value of £25 or over.

I recognise that it is an offence pursuant to s.34 of the Localism Act 2011 for a Member to -

- (1) fail to notify the Monitoring Officer of a disclosable pecuniary interest before the end of 28 days beginning with the date when the member became aware of the matter; or
- (2) provide information that the member knows to be false or misleading; or
- (3) provide information being reckless as to whether it is true and not misleading.

I also acknowledge that it may be a breach of the Members' Code of Conduct to:-

- (1) fail to register or disclose a disclosable pecuniary interest; or
- (2) fail to register with the Monitoring Officer any gift or hospitality with an estimated value of at least £25 within 28 days of its receipt; or
- (3) fail to register with the Monitoring Officer any significant gift or hospitality that I have

been offered but have refused to accept.
