GENERAL NOTICE OF REGISTRABLE INTERESTS**

I, (INSERT NAME).....JONATHAN SOLOMONS..... a Member of Three Rivers District Council, set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and I have put "none " where I have no such interests under any heading.

Registering Interests

Within 28 days of becoming a Member or your re-election or re-appointment to office you must register with the Monitoring Officer the interests which fall within the categories set out in **Table 1 (Disclosable Pecuniary Interests)** which are described in 'The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012'. You should also registered details of your other personal interests which fall within the categories set out in **Table 2 (Other Registerable Interests)**.

"Disclosable pecuniary interest" means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Table 1 below.

"Partner" means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

1. You must ensure that your register of interest is kept up-to-date and within 28 days of becoming aware of any new interest, or of any change to a registered interest, notify the Monitoring Officer.
2. A 'sensitive interest' is an interest which, if disclosed, could lead to the Councillor, or a person connected with the Councillor, being subject to violence or intimidation.
3. Where you have a 'sensitive interest' you must notify the Monitoring Officer with the reasons why you believe it is a sensitive interest. If the Monitoring Officer agrees they will withhold the interest from the public registered.

The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests following your election or re-election, or when you became aware that you had a disclosable pecuniary interest relating to a matter on which you were acting alone. Contracts Any contract which is made between you, or your spouse or civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and the council - (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged. - (2) provide information that the member knows to be false or misleading; or
- (3) provide information being reckless as to whether it is true and not misleading.

I also acknowledge that it may be a breach of the Members' Code of Conduct to:-

- (1) fail to register or disclose a disclosable pecuniary interest; or
- (2) fail to register with the Monitoring Officer any gift or hospitality with an estimated value of at least £25 within 28 days of its receipt; or
- (3) fail to register with the Monitoring Officer any significant gift or hospitality that I have been offered but have refused to accept.
